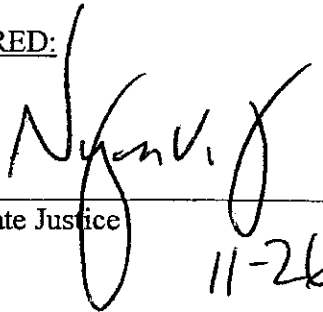

7. That this proceeding is now closed and may be reopened only upon the filing of a Motion.

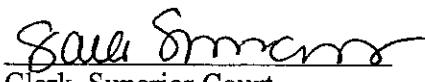

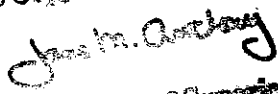
