New England Waterproofing is a Massachusetts corporation, Tax ID #042848445 and RI ID # 000117608. Our RI charter was revoked in RI in 2002 and we are seeking to reinstate and bring current our charter in RI.

Please find enclosed:

- Certificate of Good Standing from the RI Division of Taxation,
- Change of Registered Agent (Form 640) and a check for the fee
- The annual report filings and a check for the required fees and penalties, for the years 2002 – 2010 for New England Waterproofing, Inc.

Over the course of this time period (2002 – 2010), ownership of the corporation has changed, as well as its officers and directors. I am currently the sole shareholder, sole director and fill all officer positions (President, Secretary and Treasurer). As such, and because I do not have the ability to get the signature of the previous President of the corporation (2002-2004), I have signed all the annual reports as the current President of the corporation.

The sole owner, director and President from 2002-2005 was Wayne Fortier, also the owner of record prior to the revocation of the RI charter. In early 2006, Wayne Fortier died in an accident. At that time, the executor of his Estate, Stephanie Mouse, was appointed the shareholder and voted in two directors, Robert Barton and John Fortier. Those directors voted to make me President of the corporation and Stephanie Mouse the



Secretary and Treasurer. This information is shown on the 2005, 2006 and 2007 MA Annual Reports and has been replicated for the RI filings for those years.


The business was eventually inherited by his brother, David Fortier, who became the majority shareholder, a director and the Secretary and Treasurer in 2008. I remained as President and was also named a director. The RI filing for 2008 matches that information.

On December 31, 2008, I purchased the business from David Fortier and became the sole shareholder, director, President, Secretary and Treasurer of New England Waterproofing, Inc.

Please let me know if you have any questions or there is any other action I need to take to complete the reinstatement of our charter with the State of Rhode Island.
