The managing member of R & R Enterprises, LLC has decided to liquidate & dissolve the above named Rhode Island limited liability company as of October 31, 2010.

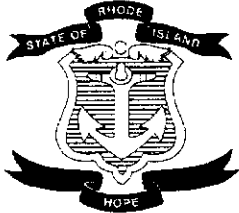
