Articles of Incorporation**

(Chapter 7-1.2- of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Special Blend Co.

This is a close corporation pursuant to § 7-1.2-1701 of the General Laws, 1956, as amended. (Uncheck if inapplicable.)

ARTICLE V

Additional provisions, if any, not inconsistent with Chapter 7-1.2 which the incorporators elect to have set forth in these Articles of Incorporation:

(A) ACTION BY THE SHAREHOLDERS PURSUANT TO RHODE ISLAND GENERAL LAWS, (JULY 1, 2005), AS AMENDED, SECTION 7-1.2-707 AUTHORIZED.

(B) NO DIRECTOR OR SHAREHOLDER UNDERTAKING TO EXERCISE THE RESPONSIBILITIES OF A DIRECTOR SHALL HAVE PERSONAL LIABILITY TO THE CORPORATION OR TO ITS SHAREHOLDERS FOR MONETARY DAMAGES FOR BREACH OF SUCH DIRECTOR'S OR SHAREHOLDER'S DUTY AS A DIRECTOR OR, IN THE CASE OF A SHAREHOLDER, DUTY AS A PERSON UNDERTAKING TO EXERCISE THE RESPONSIBILITIES OF A DIRECTOR; PROVIDED THAT THIS PROVISION SHALL NOT ELIMINATE OR LIMIT THE LIABILITY OF SUCH DIRECTOR OR SHAREHOLDER FOR: (I) ANY BREACH OF SUCH DIRECTOR'S OR SHAREHOLDER'S DUTY OF LOYALTY TO THE CORPORATION OR ITS SHAREHOLDERS; (II) ACTS OR OMISSIONS NOT IN GOOD FAITH OR WHICH INVOLVE INTENTIONAL MISCONDUCT OR A KNOWING VIOLATION OF LAW; OR (III) LIABILITY IMPOSED PURSUANT TO THE PROVISIONS OF RHODE ISLAND GENERAL LAWS 7-1.2-814, AS AMENDED.
