# Attachment to Articles of Amendment to the Articles of Incorporation of Duggan & Associates, Inc.

#### **Amendments**

- A. Article 1 is amended by striking the words "This is a close corporation pursuant to 7-1.1-51 of the General Laws, 1956, as amended)" so that the corporation is no longer a close corporation.
- B. Article 4 is hereby amended to read in its entirety as follows:
  - "4. The aggregate number of shares which the corporation shall have authority to issue is one million (1,000,000) shares of common stock, \$.001 par value ('Common Stock')."
- C. Article 6 is hereby amended to read in its entirety as follows:
  - "6.
