**Non-Profit Corporation
Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Jamestown Community Piano Association

ARTICLE II

The period of its duration is Perpetual ___

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

The purposes for which the Jamestown Community Piano Association is organized are:

- a) To maintain the Jamestown Community Piano for use by and for the people of Jamestown
- b) To sponsor concerts and recitals in Jamestown that feature the piano.
- c) To encourage performance of piano music of all kinds and the use of the community-owned piano by all professional and amateur pianists in Jamestown.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THE JAMESTOWN COMMUNITY PIANO ASSOCIATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE PURPOSES AS DESCRIBED IN SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED (THE "CODE"). THE CORPORATION SHALL NOT ENGAGE, OTHERWISE THAN AS AN INSUBSTANTIAL PART OF ITS ACTIVITIES, IN ACTIVITIES WHICH IN THEMSELVES ARE NOT IN FURTHERANCE OF ONE OR MORE PURPOSES EXEMPT FROM TAXATION UNDER THE CODE.

UPON DISSOLUTION OF THE CORPORATION, THE BOARD OF DIRECTORS SHALL, AFTER PAYING OR MAKING PROVISION FOR THE PAYMENT OF ALL LIABILITIES OF THE CORPORATION, DISTRIBUTE ALL REMAINING ASSETS OF THE CORPORATION TO AND AMONG ANY EXISTING NONPROFIT CORPORATIONS THAT QUALIFY UNDER THE PROVISIONS OF SECTION 501(C)(3) OF THE CODE AND ARE ORGANIZED FOR THE PURPOSE OF ENCOURAGING MUSICAL EXPRESSION IN JAMESTOWN.
