Pursuant to the provisions of Section 7-6-40 of the General Laws of Rhode Island, 1956, as amended, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is Friends of B'Nai Israel Cemetery

2. The following amendment to the Articles of Incorporation was adopted by the corporation:

3. Amend Section 3 as follows:

The specific purpose for which the corporation is organized is: To raise funds to help maintain the cemetery of Congregation B'Nai Israel in Woonsocket, Rhode Island which promotes Jewish funerals, memorial services, and religious burials within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future tax code.

4. Add the following provision:

Upon the dissolution of this corporation its assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
