ARTICLE I

1. EXCEPT FOR THOSE ACTIONS EXCLUDED BY SECTION 7-16-21(B)(1)(2) AND (3) OF THE RHODE ISLAND LIMITED LIABILITY COMPANY ACT, ANY ACTION REQUIRED TO

BE TAKEN AT A MEETING OF THE MEMBERS, OR ANY OTHER ACTION WHICH MAY BE TAKEN AT A MEETING OF THE MEMBERS, MAY BE TAKEN WITHOUT A MEETING IF A CONSENT IN WRITING, SETTING FORTH THE ACTION SO TAKEN, SHALL BE SIGNED BY ALL THE MEMBERS ENTITLED TO VOTE WITH RESPECT TO THE SUBJECT MATTER THEREOF.

2. NO OPERATING MANAGER OR OFFICER SHALL HAVE PERSONAL LIABILITY TO THE COMPANY OR TO ITS MEMBERS FOR MONETARY DAMAGES FOR BREACH OF SUCH OPERATING MANAGER OR OFFICER'S DUTY AS AN OPERATING MANAGER OR OFFICER PROVIDED THAT THIS PROVISION SHALL NOT ELIMINATE OR LIMIT THE LIABILITY OF SUCH OPERATING MANAGER OR OFFICER: (I) FOR ANY BREACH OF THE OPERATING MANAGER OR OFFICER'S DUTY OF LOYALTY TO THE COMPANY OR TO ITS MEMBERS; (II) FOR ACTS OR OMISSIONS NOT IN GOOD FAITH OR WHICH INVOLVE INTENTIONAL MISCONDUCT OR A KNOWING VIOLATION OF LAW; (III) UNDER §7-16-32 OF THE RHODE ISLAND LIMITED LIABILITY COMPANY ACT; OR (IV) FOR ANY TRANSACTION FROM WHICH THE OPERATING MANAGER OR OFFICER DERIVED AN IMPROPER PERSONAL BENEFIT.

3. THE OWNERSHIP OF THE COMPANY IS SUBJECT TO TRANSFER RESTRICTIONS CONTAINED IN ITS OPERATING AGREEMENT AND COPIES THEREOF ARE ON FILE AT THE REGISTERED OFFICE OF THE COMPANY. INTERESTS OF MEMBERS OF THE COMPANY ARE TRANSFERABLE ONLY UPON COMPLIANCE WITH THE PROVISIONS OF SAID TRANSFER RESTRICTIONS.

4. ALL CAPITALIZED TERMS USED IN THIS EXHIBIT A HAVE THE MEANINGS ASSIGNED TO THEM IN THE OPERATING AGREEMENT.
