**ARTICLES OF INCORPORATION**

The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws of Rhode Island, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

- The name of the corporation is Tanzania Education Resource Network (TERN)
- The period of its duration is (if perpetual, so state) perpetual
- The specific purpose or purposes for which the corporation is organized are:  
The Tanzania Education Resource Network (TERN) is an educational non-profit that provides 1) resources to students and faculty living in Tanzania and 2) education on issues related to East Africa to students and faculty living in the United States. TERN provides books and scholarships to K-12 schools and colleges in Tanzania, while also providing scholarships to students in that country. In addition, the organization supports after-school programs in several parts of Tanzania.  
This corporation is organized and operated exclusively for educational purposes within the meaning of 501(c)(3) of the Internal Revenue Code.
- Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:  
The property of this corporation is irrevocably dedicated to educational purposes. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for educational purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.
