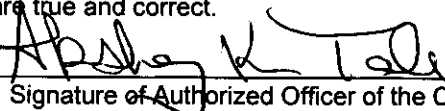
1. The name of the corporation is Medical Homes Investment Corporation

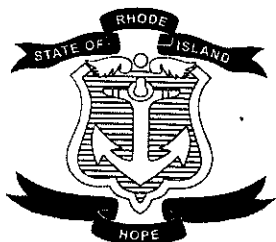
