Pearsall of the said Trust pursuant to the Federal Trust Act of 1968. There shall be no legal claim against the Trust or beneficiary as ruled by the U.S. Supreme Court Justice O'Connor held by action to disqualify a beneficiary of a Trust based on reason of mental defect or disease and or commitment to a State, Federal or Private Mental Hospital is a improper action that would Violate a beneficiary's 1st and 14th ammendment rights under due process of law, is constitutionally protected as set forth in Drop vs Missouri 95 S. At no time shall any civil commitment be used as evidence to disqualify the beneficiary, Roger P. Pearsall of the above entitled trust.
