Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Performing Arts & Creative Education Solutions Consulting

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

EXCLUSIVELY FOR EDUCATIONAL PURPOSES UNDER SECTION 501(C)3 OF THE
INTERNAL
REVENUE
CODE - INCLUDING, BUT NOT LIMITED TO: - THE PROVIDING OF FREE OR SUBSIDIZED
EDUCATIONAL
PROGRAMS TO THE PUBLIC, ESPECIALLY LOW-INCOME OR OTHERWISE
DISADVANTAGED YOUTH
IN
GENERAL.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

- A. NO PART OF THE NET EARNINGS OF THE CORPORATION SHALL INURE TO THE
BENEFIT OF ANY PRIVATE SHAREHOLDER OR INDIVIDUAL.
B. UPON DISSOLUTION, THE NET ASSETS OF THE CORPORATION SHALL BE
DISTRIBUTED TO ONE OR MORE EDUCATIONAL OR CHARITABLE ORGANIZATIONS
DESCRIBED IN SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OR STATE OR
LOCAL GOVERNMENTAL ORGANIZATIONS HAVING AIMS SIMILAR TO THOSE OF THE
CORPORATION, AS DETERMINED BY THE DIRECTOR. IN THE EVENT NO
DETERMINATION IS MADE, THE FOLLOWING SHALL BE THE BENEFICIARY OF THE NET
ASSETS OF
THE CORPORATION: THE JOHN HOPE SETTLEMENT HOUSE IN PROVIDENCE IN THE
STATE OF
RHODE ISLAND AND PROVIDENCE PLANTATIONS.
C. THE CORPORATION SHALL HAVE A SINGLE MEMBER, WHICH IS WILLIAM ROBERT

BUCHANAN.

THE MEMBER SHALL HAVE THE RIGHT TO VOTE ON ALL AMENDMENTS TO THESE ARTICLES OF INCORPORATION.

D. THE BOARD OF DIRECTORS OF THE CORPORATION SHALL BE ELECTED BY THE MEMBER AND ANY DIRECTOR OR DIRECTORS MAY BE REMOVED WITHOUT NOTICE OR CAUSE BY THE DIRECTOR.

E. THE CORPORATION SHALL NOT DISCRIMINATE ON THE BASIS OF RACE, COLOR, NATIONAL ORIGIN, ETHNIC ORIGIN, OR SEXUAL ORIENTATION IN THE ADMINISTRATION OF ITS EDUCATIONAL POLICIES, ADMISSION POLICIES, SCHOLARSHIP AND LOAN PROGRAMS, AND ATHLETIC AND OTHER SCHOOL-ADMINISTERED

PROGRAMS. THE REQUIREMENTS OF THIS ARTICLE SHALL BE INCORPORATED INTO EACH

CONTRACT THE CORPORATION ENTERS INTO WITH ANY PARTY FOR THE MANAGEMENT OR

OPERATION OF PERFORMING ARTS & CREATIVE EDUCATION SOLUTIONS CONSULTING.
