Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

**ARTICLE I**

The name of the corporation is LoveRI

**ARTICLE II**

The period of its duration is  Perpetual

**ARTICLE III**

The specific purpose or purposes for which the corporation is organized are:

To pray and work together so that southeastern New England churches, individually, congregationally, and cooperatively, practice a lifestyle of praying, caring, and sharing the good news of Jesus Christ.

**ARTICLE IV**
