Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Smithfield Youth Field Hockey Club

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

This non-profit athletic club is being formed to give children grades 1 - 8, the opportunity to learn and play the sport of field hockey.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THE MANAGEMENT AND AFFAIRS OF THE SMITHFIELD YOUTH FIELD HOCKEY CLUB SHALL BE AT ALL TIMES UNDER THE DIRECTION OF A BOARD OF DIRECTORS, WHOSE OPERATIONS IN GOVERNING SYFHC SHALL BE DEFINED BY STATUTE AND BY THE CORPORATIONS BY-LAWS. NO MEMBER OR DIRECTOR SHALL HAVE ANY RIGHT, TITLE OR INTEREST IN OR TO ANY PROPERTY OF THE CORPORATION.
