TO VACATE THE FORFEITURE OR REVOCATION OF THE CHARTER OF NEW ENGLAND CARPET CONSULTANTS, INC.

#### It is enacted by the General Assembly as follows:

- 1 SECTION 1. The time within which NEW ENGLAND CARPET CONSULTANTS,
- 2 INC., incorporated February 26, 1986 shall file the reports for the years 1998, 1999, 2000, 2001,
- 3 2002, 2003, 2004, 2005, 2006, 2007, 2008, 2009, and 2010 as required under the provisions of
- 4 section 7-6-90 of the general laws of Rhode Island, 1956, is hereby extended to the 31st day of
- 5 December, A.D., 2011 if said corporation shall file in the office of the Secretary of State before
- 6 December 31, 2011, the reports which it should have filed in the said years and shall pay to the
- 7 Secretary of State the filing fees therefore, having previously thereto paid to the General
- 8 Treasurer for the use of the state such sum as the Attorney General shall decide should be paid by
- 9 said corporation as a compromise for the penalty or penalties for its failure to file such reports
- 10 then the forfeiture or revocation of the charter of said corporation shall thereupon, to wit, upon
- 11 the filing of said reports and the payment of said fees, be vacated and said corporation shall
- 12 thereupon be entitled to all of the privileges, benefits and powers and subject to the same duties
- 13 and liabilities as though no forfeiture or revocation of its said charter had taken place.
- 14 SECTION 2. This act shall take effect upon passage.
