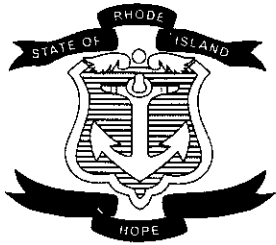
1. The name of the corporation is Edwards and Kelcey, Inc.
