**ARTICLE I**

The name of the corporation is I-195 Redevelopment District

**ARTICLE II**

The period of its duration is Perpetual  7/8/2032

**ARTICLE III**

The specific purpose or purposes for which the corporation is organized are:

Pursuant to The I-195 Redevelopment Act of 2011, Rhode Island General Laws 42-64.14-1 et seq., and as authorized by the I-195 Redevelopment District Commission on December 12, 2011, the I-195 Redevelopment District is authorized, created and established for the purposes of : (a) creating a state-local-private sector partnership to plan, implement, administer and oversee the redevelopment of the surplus I-195 properties; and (b) authorizing, providing for, and facilitating the consolidated exercise of development and redevelopment powers existing at the state and local levels.


