TO VACATE THE FORFEITURE OR REVOCATION OF THE CHARTER OF IMPERIAL
COURT OF RHODE ISLAND AT PROVIDENCE

It is enacted by the General Assembly as follows:

- 1 SECTION 1. The time within which Imperial Court of Rhode Island at Providence,
2 incorporated March 1, 1994, shall file the reports for the years 1998, 1999, 2000, 2001, 2002,
3 2003, 2004, 2005, 2006, 2007, 2008, 2009, 2010, and 2011 as required under the provisions of
4 section 7-6-90 of the general laws of Rhode Island, 1956, is hereby extended to the 31st day of
5 December, A.D., 2011, if said corporation shall file in the office of the Secretary of State before
6 December 31, 2011, the reports which it should have filed in the said years and shall pay to the
7 Secretary of State the filing fees therefore, having previously thereto paid to the General
8 Treasurer for the use of the state such sum as the Attorney General shall decide should be paid by
9 said corporation as a compromise for the penalty or penalties for its failure to file such reports
10 then the forfeiture or revocation of this charter of said corporation shall thereupon, to wit, upon
11 the filing of said reports and the payment of said fees, be vacated and said corporation shall
12 thereupon be entitled to all of the privileges, benefits and powers and subject to the same duties
13 and liabilities as though no forfeiture or revocation of its said charter had taken place.
14 SECTION 2. This act shall take effect upon passage.
