Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

**ARTICLE I**

The name of the corporation is Morijah Haitian Adventist Ministries, Inc.

**ARTICLE II**

The period of its duration is  Perpetual

**ARTICLE III**

The specific purpose or purposes for which the corporation is organized are:

The organization's Vision Statement and Purpose consist of four main points:

- First, to present the Good News of the Gospel of JESUS-CHRIST and the three Angels' Messages in order to make of every receptive child of God a disciple of Christ. (Matt. 28:19-20).
- Second, to foster the redemptive power of love, solidarity, tolerance, and fraternity among all God's Children, regardless of age, education, and ethnicity. (Matt. 5:44-47). Develop people to spiritual maturity through Bible studies, small groups, seminars, advances, and Sabbath school for our members. Equip every believer for significant ministry by helping them discover the gifts and talents GOD gave them.
- Third, to raise up and establish a strong local church which will challenge, penetrate, influence and impact the people of Pawtucket and Rhode-Island. Make Morijah SDA Church a place where the hurting, the depressed, the frustrated, and the confused can find love acceptance, help, hope, forgiveness, guidance and encouragement. To promote the reintegration, rehabilitation and the reconnection of humanity to Christ. This will be accomplished by: feeding the hungry, giving drink to the thirsty, providing housing for the homeless, clothing the naked, educating the youth, guiding the little children, visiting the sick and those who are incarcerated and preparing them for the imminent return of our Lord and Savior Jesus Christ. (Matt. 25:34-46)
- Fourth, to harness the resources of the church body (time, spiritual gifts, wealth), in order to promote spiritual, physical, educational, social, and financial self-sufficiency in the community. (3 John 2).
