Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Heart of Worship Event Ministries

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

Within the bounds set by the Magisterium of the Roman Catholic Church, Heart of Worship Event Ministries, seeks to foster a deep attachment to Christ Really and Truly Present in the Eucharist of the Holy Catholic Church in all who attend events to be held throughout the year in the Diocese of Providence and beyond. Heart of Worship Events serve the express end of promoting the Unity and Power of the Church that has it's source in the Eucharist itself, by promoting the realization of and faith in the True Presence of Christ there--in His Body, Blood, Soul, and Divinity. This is accomplished at Events through Adoration of the Blessed Sacrament, Preaching by the Priesthood, well performed, modern worship music, a procession of the Blessed Sacrament where each individual has the opportunity to touch the humeral veil, and the opportunity for confessions. This will be done in a darkened and professionally lit atmosphere for purposes of allowing for each soul to hide or loose itself in the worship atmosphere and space.
