ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws of Rhode Island, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

- The name of the corporation is QuahogCon
- The period of its duration is (if perpetual, so state) perpetual.
- The specific purpose or purposes for which the corporation is organized are:
To advance education and scientific research in information security and independent manufacturing,
and for any other lawful purpose permitted to organizations that qualify as exempt under Section
501(c)(3) of the Internal Revenue Code or the corresponding section of any future United States Tax
Code; notwithstanding any other provision of these articles, the Corporation shall not carry on any
other activities not permitted to be carried on (a) by a corporation exempt from federal income tax
under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future
federal tax code, or (b) by a corporation, contributions to which are deductible under section
170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:
Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes
within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section
or the corresponding section of any future federal tax code; any such assets not so disposed of
shall be disposed of by the Superior Court of Providence County exclusively for such purposes or to
organizations operated, as said Court shall determine, exclusively for such purposes.
