Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Rhode Island Black Civic Fund

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

The purpose of The Black Civic Fund is to:

Encourage our constituency to take a more active role in government and business in the State of Rhode Island.

Provide information to the public about the voting record of candidates for public office.

Provide information about laws that can benefit or harm our constituency.

Provide an advantage in political elections to candidates that support the needs of our constituency by soliciting and receiving contributions to be used to make political campaign donations.

Provide a way for our constituency to introduce desired legislation into the Rhode Island General Assembly and the United States Congress by building relationships with elected officials and lobbying the Rhode Island General Assembly and the United States Congress. This also includes presenting our positions to local governments in the State of Rhode Island.

Promote equal treatment of our constituency by law enforcement in the State of Rhode Island.

Support the activities of other organizations that support the needs of our constituency.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THE BLACK CIVIC FUND SHALL BE MANAGED AND GOVERNED BY A BOARD OF DIRECTORS, ALSO KNOWN AS BOARD OF DIRECTORS. THE BOARD OF DIRECTORS SHALL BE REGULATED BY THE BYLAWS. THE BOARD OF DIRECTORS SHALL MEET AT THE DISCRETION OF THE CHAIR AT ANY TIME. THERE SHALL ALSO BE SUBCOMMITTEES APPOINTED AND CHAIRED BY THE OFFICERS SERVING ON THE BOARD. THE CHAIR SHALL FORM AD-HOC COMMITTEES TO ASSIST IN RISING AND COLLECTING FUNDS FOR THE BLACK CIVIC FUND AT ANY TIME DEEMED NECESSARY BY THE CHAIR OR THE BOARD OF DIRECTORS.
