 - (4) any transaction from which the manager derived an improper personal benefit, unless such transaction was with the consent of a majority of the disinterested managers.
- 6.3 The limited liability company shall indemnify any member, manager, agent, or employee, past or present, of the limited liability company (an "Indemnified Person") to the fall extent permissible pursuant to Section 4(k) of the Act; provided, however, that the limited liability company shall not indemnify any Indemnified Person for:

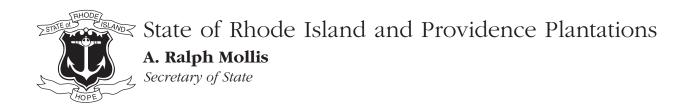
