**Non-Profit Corporation
Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is The Center for Sexual Pleasure and Health

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

The Center for Sexual Pleasure and Health provides sex-positive sexuality education, research opportunities, cultural dialogue, and support to professional and non-professional audiences by means of classes, workshops, performances, social gatherings, practical skills-building events, and similar events. The Center also maintains a research library relevant to these purposes.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

IN FURTHERANCE, AND NOT IN LIMITATION OF THE POWERS CONFERRED BY STATUTE, THE BYLAWS ARE EXPRESSLY AUTHORIZED TO BE AMENDED OR REPEALED, IN WHOLE OR IN PART, BY A MAJORITY VOTE OF THE DIRECTORS.

NO DIRECTOR SHALL BE PERSONALLY LIABLE TO THE CORPORATION FOR MONETARY DAMAGES FOR BREACH OF FIDUCIARY DUTY AS DIRECTOR, NOTWITHSTANDING ANY PROVISION OF LAW IMPOSING SUCH LIABILITY, PROVIDED HOWEVER THAT THIS PROVISION SHALL NOT ELIMINATE THE LIABILITY OF A DIRECTOR, TO THE EXTENT THAT SUCH LIABILITY IS IMPOSED BY APPLICABLE LAW...

A. FOR ANY BREACH OF THE DIRECTOR DUTY OF LOYALTY TO THE CORPORATION
B. FOR ACTS OR OMISSIONS NOT IN GOOD FAITH, OR WHICH INVOLVE INTENTIONAL MISCONDUCT OR KNOWING VIOLATIONS OF LAW
C. FOR ANY TRANSACTION FROM WHICH THE DIRECTOR DERIVED AN IMPROPER PERSONAL BENEFIT.

UPON THE DISSOLUTION OF THE CORPORATION, ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE.
