(Chapter 7-1.2- of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Yankee Soldering Technology Inc.

This is a close corporation pursuant to § 7-1.2-1701 of the General Laws, 1956, as amended. (Uncheck if inapplicable.)

ALL DECISIONS ABOUT THE OPERATION OF THE BUSINESS ARE THE REPOSIBILITY OWNERS OF 30% OF THE STOCK OR MORE. NO INTERFERENCE FROM STOCKHOLDERS WITH 30 SHARES OR LESS IN THE BUSINESS ACTIVITY IS ALLOWED.
