Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is John D. Cuda Charitable Fund, Inc.

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

provide scholarships for deserving high school students with musical talent and raise funds for the Juvenile Diabetes Research Foundation International.

provide support to charitable organizations which give financial aid to music students at the high school level and to organizations that benefit individuals with juvenile diabetes.
