Articles of Amendment**

(Section 7-6-40 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is ASSEMBLY OF GOD EBENEZER

If the entity's name is changing, state the new name: Revival Church for the Nations in Newport

ARTICLE II

If the corporate purpose is changing, so state:

TO ESTABLISH AND MAINTAIN A CHURCH AND TO PROVIDE A PLACE OF PUBLIC WORSHIP FOR THE SAME; TO ESTABLISH AND MAINTAIN CLASSES FOR RELIGIOUS INSTRUCTION OF YOUTH AND ADULTS AND TO ESTABLISH AND EXPAND DOMESTIC AND FOREIGN MISSIONARY ENTERPRISES.

TO THESE ENDS, THE CORPORATION MAY ADOPT AND ESTABLISH BY-LAWS, AND MAKE ALL RULES AND REGULATIONS DEEMED NECESSARY AND EXPEDIENT FOR THE MANAGEMENT OF ITS AFFAIRS, IN ACCORDANCE WITH LAW AND NOT INCONSISTENT WITH THESE ARTICLES OF ORGANIZATION; AND TO TAKE, MANAGE, HOLD AND DISPOSE OF THE PROPERTY, REAL AND PERSONAL OF SAID CORPORATION; TO RECEIVE SUBSCRIPTIONS AND DONATIONS OF REAL AND MORTGAGE OR OTHERWISE ENCUMBER ANY OF ITS PROPERTY; AND TO SELL AND CONVEY THE SAME. SUBJECT TO SUCH LIMITATIONS AND CONDITIONS AS ARE OR MAY BE PRESCRIBED BY LAW, THE CORPORATION SHALL ALSO EXERCISE ALL POWERS NECESSARY OR INCIDENTAL TO THE POWER SO CONFERRED OR CONDUCIVE TO THE ATTAINMENT OF THE PURPOSES OF THE CORPORATION AS MAY BE EXERCISED BY AN ORGANIZATION EXEMPT UNDER SECTION 501(C) (3) OF THE INTERNAL REVENUE SERVICE.

THIS ORGANIZATION IS A FELLOWSHIP OF BELIEVERS. THEREFORE, ANY BELIEVER IN JESUS CHRIST WHOLE LIFE IS FREE FOR UNREPENTANT PERSISTENCE IN SIN DAMAGING TO THE TESTIMONY OF THE CHURCH WHO DOES NOT PROPAGATE TEACHING CONTRARY TO OUR FAITH MAY SHAPE IN MEETING AND ACTIVITIES. MEMBERSHIP FOR SPECIAL COMMITTEES MUST BE REVIEWED BY THE COUNCIL
