Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is The 24 Hour Music Project: To Stop Domestic Violence, Ltd.

ARTICLE II

The period of its duration is Perpetual ___

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

The 24 Hour Music Project: To Stop Domestic Violence is a non-profit initiative created to raise awareness and funding to assist victims of domestic violence. Additionally, all proceeds will be used to create education programs to assist with helping individuals to recognize warning signs of abusive relationships and provide direction on how to find safe haven, food, shelter, and counseling.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

NO PERSON OTHER THAN THE LISTED INCORPORATOR SHALL BE ABLE TO ACT ON THE BEHALF OF THE 24 HOUR MUSIC PROJECT: TO STOP DOMESTIC VIOLENCE WITHOUT THE EXPRESSED PERMISSION, IN WRITING, OF BEING ABLE TO DO SO. ALL RIGHTS TO MUSIC, IMAGES, VIDEO, AND PROMOTIONAL, AND EDUCATIONAL CONTENT CREATED IN CONJUNCTION WITH THE PROJECT ARE SOLELY OWNED BY THE LISTED INCORPORATOR. ANY PERSONS ACTING ON BEHALF OF THE PROJECT WITHOUT THE EXPRESSED PERMISSION OF THE LISTED INCORPORATOR WILL BE SUBJECT TO PROSECUTION.
