BE SHARED EQUALLY. IF ONE OWNER LEAVES THEIR PERCENTAGE WILL BE EQUALLY DISTRIBUTED TO THE REMAINING OWNERS. ANY NEW OWNERS WILL HAVE TO BE APPROVED UNANIMOUSLY BY WRITTEN CONSENT OF THE MEMBERS. WITH REGARDS TO MANAGEMENT DECISIONS, PER CAPITA VOTING SHALL BE USED IN THE SITUATION THAT A FORMAL VOTE IS NECESSARY AND MAJORITY VOTES WILL SUCCEED.
