**6. Brief Description of the Character of the Affairs Which are Actually Conducted in Rhode Island**

In addition to the original purposes for which the corporation was formed, as amended, the purposes of the corporation set forth in Article Third of its Articles of Incorporation shall be expanded to include the following:

(a) To provide services and support to the elderly, veterans, physically handicapped and mentally handicapped ("Target Population") and their families;

(b) To develop programs that provide for new opportunities and greater community inclusion for the Target Population and their families;

(c) To provide information, referrals and resources to the Target Population, their families and the community;

(d) To identify, develop and operate community projects which serve to support the Target Population, and others in need, directly and indirectly;

(e) To act as a resource and provide financial and technical support to organizations that provide services to the Target Population. Financial support may include credit, funds, capital, gifts, guarantees and all other lawful forms of assistance;

(f) To work cooperatively with Blackstone Valley Development Corporation ("BVDC"), a Rhode Island

charitable corporation which is tax-exempt under Section 501(c)(3) of the Internal Revenue Code, and, without limitation, acquire, develop, own and operate real property in connection with projects sponsored by BVDC or its affiliated entities;

(g) To acquire, construct, rehabilitate, convert, operate and manage housing facilities for the Target Population and to provide related social services within the housing facilities which are consistent with community needs and desires;

(h) To acquire, construct, rehabilitate, convert, operate and manage affordable low-income housing consistent with all applicable state and federal safe harbor requirements and to provide related social services within such housing facilities which are consistent with community needs and desires; and

(i) To engage in any and all lawful acts and activities for which a corporation may be organized under the Rhode Island Nonprofit Corporation Act, as amended.
