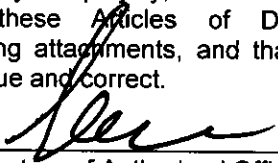
1. The name of the corporation is FRISELLA ENGINEERING, INC.

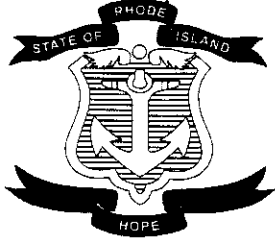
The assets of FRISELLA ENGINEERING, INC. having been sold, and otherwise disposed of, there being no reason to keep the corporation open, it is VOTED:
