EXPLANTORY ADDENDUM

Inofin Incorporated

Relating to Annual Report for 2012

Inofin is currently a debtor in a Chapter 7 bankruptcy proceeding pending in the United States Bankruptcy Court for the District of Massachusetts (Docket No. 11-11010). The bankruptcy was filed as an involuntary proceeding on February 9, 2011. An Order for Relief entered on February 16, 2011 establishing Inofin as a debtor in bankruptcy. The same day an Order was issued appointing Mark G. DeGiacomo, Esq. as the Chapter 7 Trustee of Inofin's bankruptcy estate. Attorney DeGiacomo has been operating Inofin pursuant to continuing grants of authority from the Bankruptcy Court since February 23, 2011.

One of Attorney DeGiacomo's first acts of Trustee involved dismissing Inofin's officers and directors. Those officers and directors have not had any authority or involvement with the conduct of Inofin's business since Attorney DeGiacomo's appointment. While Attorney DeGiacomo is not specifically an elected director or officer of Inofin, he represents the closest approximation of a director or officer. For this reason and because the Annual Report Form requires the listing of both officers and directors, Attorney DeGiacomo is listed as Inofin's only current officer and director.
