Articles of Amendment**

(Section 7-6-40 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is The 24 Hour Music Project: To Stop Domestic Violence, Ltd.

ARTICLE II

THE 24 HOUR MUSIC PROJECT: TO STOP DOMESTIC VIOLENCE IS A NON-PROFIT INITIATIVE CREATED TO RAISE AWARENESS AND FUNDING TO ASSIST VICTIMS OF DOMESTIC VIOLENCE. ADDITIONALLY, ALL PROCEEDS WILL BE USED TO CREATE EDUCATION PROGRAMS TO ASSIST WITH HELPING INDIVIDUALS TO RECOGNIZE WARNING SIGNS OF ABUSIVE RELATIONSHIPS AND PROVIDE DIRECTION ON HOW TO FIND SAFE HAVEN, FOOD, SHELTER, AND COUNSELING.

The 24 Hour Music Project, Ltd. 501c3 corporation is organized exclusively for charitable and educational purposes and for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Or organizations/families in need of charitable donations.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes. ALL RIGHTS TO MUSIC, IMAGES, VIDEO, AND PROMOTIONAL, AND EDUCATIONAL CONTENT CREATED IN CONJUNCTION WITH THE PROJECT ARE SOLELY OWNED BY THE LISTED INCORPORATOR. ANY PERSONS ACTING ON BEHALF OF THE PROJECT WITHOUT THE EXPRESSED PERMISSION OF THE LISTED INCORPORATOR WILL BE SUBJECT TO PROSECUTION.
