Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

**ARTICLE I**

The name of the corporation is Apostolic Council of New England, Inc.

**ARTICLE II**

The period of its duration is  Perpetual

**ARTICLE III**

The specific purpose or purposes for which the corporation is organized are:

The purpose of our nonprofit corporation is to promote unity among christian pastors, ministers. Leaders, churches and ministries.

1. To promote and train christian ministers.
2. To provide proper credentials to qualify ministers.
3. To provide spiritual assistance to the pastors and their churches
4. To coordinated and provide seminars for leadership in New England and other countries of Latin America.
5. To preach the gospel of Jesus Christ in Rhode Island, extending to New England, the USA and other Countries.
6. To pray to God for the Great Nation of The United States and other nations of the world.
7. To coordinate family and leadership conferences and ministerial seminars in USA and other countries.
8. Coordinated mission trips to different countries assisting the poor and the most needed.
9. To help the needed, to promote Christian Principles and Values that will build a better society.

**ARTICLE IV**

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

1. THE CENTRAL WORLD HEADQUARTERS WILL ALWAYS BE IN RHODE ISLAND
2. THE DURATION OF SERVICE FOR PRESIDENT OF THE CORPORATION IS TWO YEARS WITH ONE REELECTION.
3. THE DURATION OF SERVICE FOR THE VI-PRESIDENT IS TWO YEARS WITH ONE REELECTION.
4. THE PRESIDENT AND VICE PRESIDENT CAN SERVE UP TO TWO TERMS; THEN MUST WAIT ONE TERM TO RUN FOR THE OFFICE AGAIN.
5. TO RUN FOR PRESIDENT AND VICE PRESIDENT, THE CANDIDATE MUST HAVE

SERVE IN ANY OTHER DIRECTOR'S NOMINEE FOR THE MINIMUM OF FOUR YEARS.  
6. TO BECOME A DIRECTOR OF ANY NOMINEE, THE CANDIDATE MUST HAVE BEEN A FULL TIME MINISTER OR ITS EQUIVALENT FOR A MINIMUM OF 5 YEARS AND A MEMBER OF THE APOSTOLIC COUNCIL OF NEW ENGLAND, INC. IN GOOD STANDING FOR TWO YEARS.

7. ELECTIONS WILL BE MADE EVERY TWO YEARS ON THE MONTH OF MARCH AND THE NEW ELECTED DIRECTORS WILL TAKE OFFICE ON THE MONTH OF JUNE.

8. IF THE CORPORATION IS DISSOLVE ALL ASSETS MUST BE DONATE TO A SIMILAR ENTITY.
