Articles of Amendment

(Section 7-6-40 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

- REVIEW OF DISABILITY EVALUATIONS, DOCUMENTATION & RECORDS TO DETERMINE

ELIGIBILITY FOR SPECIAL EDUCATION SERVICES AND SUBSTANTIATE REQUESTS FOR

APPROPRIATE INSTRUCTIONAL MODIFICATIONS AND ENVIRONMENTAL ACCOMMODATIONS.

- ASSESS THE IMPACT OF SPECIFIC NEURO-DEVELOPMENTAL DISABILITIES ON ACADEMIC & SOCIAL DEVELOPMENT & ACHIEVEMENT TO ACCURATELY DEVELOP INDIVIDUAL EDUCATION PLANS (IEPS) THAT PROVIDE SCIENTIFICALLY RESEARCHED,

EVIDENCE-BASED ACCOMMODATIONS & MODIFICATIONS PROVEN TO FACILITATE POSITIVE

EDUCATIONAL & SOCIAL EXPERIENCES.

- FACILITATE COMMUNICATION & NEGOTIATION EFFORTS BETWEEN FAMILY MEMBERS,

PUBLIC SCHOOL PERSONNEL, AND MEDICAL PROFESSIONALS FOR THE EXPRESS PURPOSE

& BENEFIT OF SECURING THE MOST APPROPRIATE MODIFICATIONS & ACCOMMODATIONS

REQUIRED TO EFFECTIVELY ADDRESS EVERY ASPECT OF EACH SPECIFIC DISABILITY FOR EACH STUDENT.

- PROVIDE SHORT TERM CRISIS INTERVENTION & CONSULTATION TO FAMILIES OF CHILDREN WITH DISABILITIES TO TEACH EFFECTIVE MONITORING , REGULATING, COPING & PROBLEM SOLVING STRATEGIES THAT FACILITATE INCREASED SELF REGULATION, SOCIAL INDEPENDENCE & SELF ESTEEM.

- PROVIDE INFORMATION, REFERRAL, & SUPPORT TO FAMILIES OF STUDENTS WITH DISABILITIES TO FACILITATE COMPREHENSION OF SPECIFIC NEURO-DEVELOPMENTAL

DISABILITIES AS WELL AS SPECIFIC RIGHTS AND RESPONSIBILITIES REGARDING REASONABLE & APPROPRIATE DISABILITY ACCOMMODATIONS & MODIFICATIONS.

- NETWORK WITH & PARTICIPATE IN ACTIVITIES & EVENTS SPONSORED BY COMMUNITY-

BASED SPECIAL EDUCATION ORGANIZATIONS SERVING THE FULL SPECTRUM OF DEVELOPMENTAL DISABILITY POPULATIONS TO FACILITATE COMMUNITY AWARENESS,

TOLERANCE, & ACCEPTANCE.

- PROVIDE CONSULTATION, PROFESSIONAL DEVELOPMENT TRAINING, & TECHNICAL

ASSISTANCE TO PROMOTE AWARENESS & UNDERSTANDING OF THE STATE & FEDERAL LAWS

SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE, OR SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT, OR TO A STATE OR LOCAL GOVERNMENT, FOR A PUBLIC PURPOSE. ANY SUCH ASSETS NOT SO DISPOSED OF SHALL BE DISPOSED OF BY A COURT

OF COMPETENT JURISDICTION OF THE COUNTY IN WHICH THE PRINCIPAL OFFICE OF

THE CORPORATION IS THEN LOCATED, EXCLUSIVELY FOR SUCH PURPOSES OR TO SUCH

ORGANIZATION OR ORGANIZATIONS, AS SAID COURT SHALL DETERMINE WHICH ARE

ORGANIZED AND OPERATED EXCLUSIVELY FOR SUCH PURPOSES.
