Ladies and Gentlemen:

On November 16, 2012 the Business Calendar of the Rhode Island Superior Court entered an Order, a copy of which is enclosed, appointing me as Permanent Receiver of the assets and business of Gorman Roofing, Inc. ("Gorman"). You may have received notice of these proceedings previously regarding Gorman when I was appointed Gorman's Temporary Receiver on October 26, 2012.

A Receivership is a state court proceeding. The Receiver is an officer of the Court, appointed for the purpose of representing the interests of all creditors. Our office does not and has not represented Gorman or its principals, and has been appointed as a neutral, impartial Receiver for the immediate purpose of stabilizing Gorman's financial affairs. Ultimately, it is my intention to dispose of Gorman's assets for the highest value, subject to Court approval and after notice to all creditors and parties in interest, with the purpose of maximizing recovery for all of Gorman's creditors. Payment will then be made to those creditors with pre-petition claims in the order to which they are entitled in accordance with their respective rights.

In order that your interests be protected and to ensure that you receive notice of all pleadings in connection with the case, I have enclosed a Proof of Claim form which I suggest you complete, execute before a Notary Public, and return to me at the earliest possible date, but in no event later than March 27, 2013. Please be sure to include any and all documentation in support of your claim.

<u>ORDER APPOINTING PERMANENT RECEIVER</u>

This cause came on to be heard on November 16, 2012 before this Honorable Court, Justice Silverstein presiding, on the Petition for the Appointment of a Permanent Receiver for the Defendant corporation, and it appearing that the notice provided by the Order of this Court previously entered herein has been given, and upon consideration thereof it is hereby

ORDERED AD UDGED AND DECREED:

- 1. That William J. Delanev, of Providence, Rhode Island, be and hereby is appointed Permanent Receiver of Defendant corporation (the "Permanent Receiver"), and of all the estate, assets, effects, property and business of the Defendant corporation of every name, kind, nature and description, with all the powers conferred upon him by the General Laws and by this Order and will all powers incidental to his said office.
- 2. That the Permanent Receiver shall forthwith file herein his bond in the amount of Tep Thousand Dollars (\$10,000.00) with corporate surety thereon authorized to do business in the State of Rhode Island conditioned that he will well and truly perform the authorized.
- 3. That the Permanent Receiver be and he hereby is authorized, empowered and directed to take possession and charge of said estate, assets, effects, property and business of the Defendant corporation, including cash surrender value of any insurance owned by Defendant corporation, and to preserve the same, and he is hereby vested with title to the same; to collect and receive the debis; property and other assets and effects of said Defendant corporation, including such cash surrender value, with full power to prosecute, defend, adjust and compromise all claims and suits of, by or againg the debig proceedings relating to said estate, assets, effects and property as may in the judgment of N. Rochanent

Office of Clerk of Superior Court Counties of Providence & Bristol Providence, Rhode Island Receiver be necessary or desirable for the protection, maintenance and preservation of the property and assets of said Defendant corporation.

- 4. That this appointment is made in succession to the appointment of Temporary Receiver heretofore made by order of this Court, and the Pennanient Receiver shall take and be vested with the title to all assets, property and choses-in-action which have heretofore accrued to the Temporary Receiver with power to confirm and ratify in writing such agreements as are entered into by such Temporary Receiver and to carry out and perform the same.
- 5. That the Permanent Receiver is authorized, in his discretion, to continue the business of the Defendant corporation until further Order of this Court, and to employ such persons as may be desirable for the foregoing purposes and, in connection therewith, to use such moneys as shall come into his hands and possession, as far as the same shall be necessary, for the above purposes and for continuing the business of said Defendant corporation until further Order of this Court.
- 6. That the Permanent Receiver is authorized to incur expenses for goods and services and to punchase for each such merchandise supplies and materials as in his discretion may be necessary for continuance of the business of the Defendant corporation.
- 7. That the Permanent Receiver be and he hereby is authorized and empowered to sell, transfer and convey his right, title and interest and the right, title and interest of said Defendant corporation in and to any real property or personal property, tangible or intangible, for such sum or sums of money as to him appears reasonable and proper, at private sale or sales, provided, however, that approval is first given for such sale or sales by this Court on ex parts application by the Permanent Receiver.
- 8. That the Permanent Receiver is hereby authorized and empowered to sell at public auction any or all of the assets referred to in Paragraph 7. He is also authorized to engage an auctioneer and to insert such display ads within or without the State of Rhode Island as he deems proper advertising for such sale. Such a public auction sale conducted by the Permanent Receiver in accordance with the provisions of this paragraph shall be considered and is hereby declared to be a commercially reasonable sale, and such sale shall constitute compliance with the requirements of a commercially reasonable sale as set forth in Article 9 of the Uniform Commercial Code as enacted in Rhode Island.
- 9. That the Permanent Receiver be, and he hereby is, authorized and empowered, as soon as he has sufficient funds available, to pay all City, State and United States taxes of any kind, nature and description, including withholding taxes, as well as wages due amployees being relieved of the necessity of filing claims with the Permanent Receiver unless the amount paid or shown on the books of the Defendant corporations for acceptable to any

employee, in which case said employee may file his claim in the same manner as other creditors.

- 10. That the Permanent Receiver shall continue to discharge his duties and trusts hereunder until further order of this Court and from time to time make reports of his doings in the premises as directed by this Court; that the right is reserved to the Permanent Receiver and to the parties hereto to apply to this Court for any other or further instructions to the Permanent Receiver and that this Court reserves the right, upon such Notice, if any, as it shall deep proper, to make such further Orders herein as may be proper, and to modify this Order from time to time.
- 11. All creditors or other claimants hereby are ordered to file under oath with the Receiver at The Delaney Law Firm LLC, 91 Friendship Street. Suite One, Providence, Rhode Island 02903 on or before March 27, 2013; a statement of the foregoing, the name and address of the claimant, the name and amount of such claim, a statement of any security or her held by the claimant to which he is or claims to be entitled; and also a statement as to any preference or priority which the claimant claims to be entitled to over the claims of any other or all other claimants or creditors.
 - 12. That this Order is entered by virtue of and pursuant to this Court's equity powers.
- 13. That the commencement, prosecution, or continuance of any action, suit, arbitration proceeding, hearing, or any foreclosure, reclamation or repossession proceeding, both judicial or nonjudicial, or any other proceeding, in law, or in, equity or under any statute, or otherwise, against said Defendant corporation or any of its property. In any Court, agency, tribunal, or elsewhere, or before any arbitrator, or otherwise by any creditor, member, corporation, partnership or any other person, or the levy of any attachment, execution or other process upon or against any property of said Defendant corporation, or the taking or attempting to take into possession any property in the possession of the Defendant corporation or of which the Defendant corporation has the right to possession, by any of such parties as aforesaid, other than the Permanent Receiver designated as aforesaid, or the termination of telephone, electric, gas or any utility service to Defendant corporation, by any public utility, without obtaining approval thereof from this Honorable Court, in which connection the Permanent Receiver shall be entitled to prior notice and an opportunity to be heard, are hereby restrained and enjoined until further Order of this Court.
- 14. That Notice be given of the entry of this Order by the Clerk of Court by publication of copy of this Receivership Notice in The Revuelect Times on or before 12 2012, and by the Permanent Receiver mailing on or before the 12 date of Copy AMILY: a copy of said this Receivership Notice to each creditor and member of said Defendant comporation known as such to the Permanent Receiver, or appearing as such to the Vool of National Comporation.

May 1st and October 1st of each year, a Receivership Control Calendar Report in a coordance with Administrative Order No. 98:7.
