The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws of Rhode Island, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

- 1. The name of the corporation is HONEY'S Place, Inc.
2. The period of its duration is (if perpetual, so state) Perpetual
3. The specific purpose or purposes for which the corporation is organized are:
1. Exclusively for, and will be operated exclusively for charitable purposes
2. No part of the organization's net earnings will inure to the benefit of private individuals or shareholders and will NOT be organized or operated for the benefit of private interests.
3. This organization will NOT as a substantial part of its activities, attempt to influence legislation or participate in a political campaign for or against any candidate for public office. See attached.
4. Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:
1. The general management of the affairs of the Organization shall be vested in the Board of Directors.
2. The number of Directors shall be not less than three.
3. The annual meeting of the Board of Directors shall be held in November.
4. regular quarterly meetings shall be held in MARCH, June, September, and December.
