The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws of Rhode Island, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is Immanuel Community church of Providence.

2. The period of its duration is (if perpetual, so state) Perpetual

3. The specific purpose or purposes for which the corporation is organized are:

To conduct church services, To hold classes in religion, To impart spiritual education, To give spiritual support, including crisis counseling and spiritual counseling, To hold religious ceremonies, weddings, naming of babies, funerals and memorial services, To give prayer support, To create community outreach programs, To perform community services.

The foregoing enumeration of specific powers shall not be construed or held to limit or restrict in any manner the powers of the corporation abovementioned.

4. Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

That "Immanuel Community church of Providence," the unincorporated organization intended to be incorporated, is not a part of the General Assembly of the Presbyterian church (U.S.A) and is not subject to abide by its rules and conditions. It is a part of the American Presbyterian churches, and abides by the rules and regulations set by the General Assembly FILED the American Presbyterian churches church.
