## C E R T I F I C A T E (Limited Partnership)

- 2. The foregoing are the names and places of residence of all members of the Partnership, both General and Limited, as respectively designated.

- 5. The term of existence of the Partnership shall be from December , 1972 to December 31, 2014, unless sooner terminated in accordance with the terms of the Partnership Agreement.
- 6. The Limited Partners shall make the following cash contributions to the capital of the Partnership: Sanford Agate \$125,000; Louis Roberts \$125,000; Thomas P. Dimeo \$100.

- 12. No Limited Partner shall have the right to priority over the other Limited Partners as to contributions or as to compensation by way of income.
