- That the Receiver's First and Final Report herein, and all acts, doings, and disbursements of the 1. Receiver are hereby approved, confirmed, and ratified.
- That the Receiver's Recommendation on Allowance of Claims is approved. 2.
- That the administrative claims of financial consultant, Wolfe Corsetti & Associates, Inc. in the 3. amount of \$5,542 and SJ Corio Company in the amount of \$650 are hereby allowed and the Receiver is authorized and directed to pay such allowed administrative claims.
- That the administrative claim of the Receiver in the amount of \$78,995.26 is hereby allowed 4. and the Receiver is authorized and directed to immediately pay himself \$66,321,9 the balance of the receivership account, on account of said allowed administrative claim.
- That the Receiver and the Receiver's financial consultant are hereby discharged and the 5. Receiver's bond ordered cancelled.
- That the Receiver is hereby authorized to abandon all of the Respondent's books and records 6. and any outstanding assets.

- 7. That the Receiver is authorized to remit payment to the Receiver upon receipt of any payments of any outstanding accounts receivable.
- 8. That Respondent corporation is hereby ordered dissolved and the Receiver is directed to forward a copy of this Order to the Office of the Secretary of State for the State of Rhode Island.
- 9. That this proceeding is now closed and may be reopened only upon the filing of a motion.
