Articles of Incorporation**

(Chapter 7-1.2- of the General Laws of Rhode Island, 1956, as amended)

**ARTICLE I**

The name of the corporation is DAVID TRAN, INC

This is a close corporation pursuant to § 7-1.2-1701 of the General Laws, 1956, as amended. (Uncheck if inapplicable.)

**ARTICLE II**

A statement of all or any of the designations and the powers, preferences, and rights, including voting rights, and the qualifications, limitations, or restrictions of them, which are permitted by the provisions of Chapter 7-1.2 of the General Laws, 1956, as amended, in respect of any class or classes of shares of the corporation and the fixing of which by the articles of association is desired, and an express grant of the authority as it may then be desired to grant to the board of directors to fix by vote or votes any of them that may be desired but which is not fixed by the articles:

TO ENGAGE IN THE GENERAL SERVICES OF NAILS SERVICES AND NAILS SALON AND TO RENDER ANY RELATED SERVICES INCIDENTAL THERETO, AND IN THE GENERAL TO UNDERTAKE ALL MATTERS AS ARE AUTHORIZED FOR A NAILS AND BEAUTY SALON DOING BUSINESS IN THE STATE OF RHODE ISLAND. AND TO EXERCISE ALL POWERS AND PRIVILEGES NOW OR HEREAFTER GRANTED TO A CORPORATION UNDER THE PROVISION OF CHAPTER 7-1.2 STATE OF RHODE ISLAND, AS AMENDED FROM TIME TO TIME OR ANY SUBSTITUTE THEREFORE.

**ARTICLE III**

**ARTICLE IV**

The corporation has the purpose of engaging in any lawful business, and shall have perpetual existence until

dissolved or terminated in accordance with Chapter 7-1.2.

## ARTICLE V

Additional provisions, if any, not inconsistent with Chapter 7-1.2 which the incorporators elect to have set forth in these Articles of Incorporation:

1.) PRIOR TO THE ISSUANCE OF SHARES OF ANY CLASS OR SERIES, THE ARTICLE OF ORGANIZATION MUST SET FORTH THE REFERENCE, LIMITATIONS AND RELATIVE RIGHT OF THAT CLASS OR SERIES. THE ARTICLES MAY ALSO LIMITED OR SPECIFY THE MINIMUM AMOUNT OF CONSIDERATION FOR WHICH SHARES OF ANY CLASS OR SERIES MAY BE ISSUED. PLEASE SET FORTH THE PREFERENCE, LIMITATIONS AND RELATIVE RIGHT OF EACH CLASS OR SERIES AND, IF DESIRED, THE REQUIRED TYPE AND MINIMUM AMOUNT OF CONSIDERATION TO BE RECEIVED.

2.) ANY SHARES HOLDER WHO WISHES TO SELL HIS/HER STOCK MUST FIRST OFFER IT TO THE CORPORATION. IF THE CORPORATION AND THE SHAREHOLDER CANNOT AGREE TO A SET PRICE THEN AN INDEPENDENT APPRAISAL WILL BE EMPLOYED BY THE CORPORATION TO SET A SHARE PRICE.

3.) THE CORPORATION HAS THE ABILITY TO HOLD STOCKHOLDER'S MEETING OUTSIDE OF STATE OF RHODE ISLAND.

4.) OTHER LAWFUL PROVISIONS

(A) THE CORPORATION MAY CARRY ON ANY BUSINESS, OPERATION OR ACTIVITY REFERRED TO IN ARTICLE II TO THE SAME EXTENT AS AN INDIVIDUAL, WHETHER AS PRINCIPAL, AGENT, PARTNER, JOINT VENTURE, CONTRACTOR OR OTHERWISE.

(B) THE DIRECTORS MAY MAKE, AMEND, OR REPEAL THE BYLAWS IN WHOLE OR IN PART, EXCEPT WITH RESPECT TO ANY PROVISION THEREOF WHICH UNDER THE LAWS OF THE STATE OF RHODE ISLAND OR THE BYLAWS MAY ONLY BE MADE, AMENDED,

OR REPEALED BY THE STOCKHOLDERS.

(C) MEETING OF THE STOCKHOLDERS MAY BE HELD ANYWHERE IN THE UNITED STATES.

(D) THE DIRECTORS MAY SPECIFY THE MANNER IN WHICH THE ACCOUNTS OF THE CORPORATION SHALL BE KEPT AND MAY DETERMINE WHAT CONSTITUTES NET EARNINGS,

PROFITS AND SURPLUS; WHAT AMOUNTS, IF ANY, SHALL BE RESERVED FOR ANY CORPORATE PURPOSE; AND WHAT AMOUNTS, IF ANY, SHALL BE DECLARED AS DIVIDENDS.

(E) THE DIRECTORS MAY AUTHORIZE SHARES TO BE ISSUED FOR CONSIDERATION CONSISTING OF ANY TANGIBLE OR INTANGIBLE PROPERTY OR BENEFIT TO THE CORPORATION, INCLUDING WITHOUT LIMITATION EQUIPMENT, INVENTORY CASH, ACCOUNTS, PROMISSORY NOTES, SECURITIES, SERVICES PERFORMED, CONTRACTS FOR

SERVICES TO BE PERFORMED, OR OTHER SECURITIES OF THE CORPORATION.

(F) THE DIRECTORS SHALL DETERMINE THE ADEQUACY OF THE CONSIDERATION PAID FOR ISSUANCE OF SHARES. SAID DETERMINATION SHALL BE CONCLUSIVE INSOFAR

AS THE ADEQUACY OF THE CONSIDERATION RELATES TO WHETHER THE SHARES ARE

VALIDLY ISSUED, FULLY PAID, AND NO ASSESS

(G) THE DIRECTORS SHALL HAVE THE POWER TO FIX FROM TIME TO TIME THEIR COMPENSATION.

(H) IN THE ABSENCE OF FRAUD OR BAD FAITH, NO PERSON SHALL BE DISQUALIFIED FROM HOLDING OR EXCISING ANY OFFICE BY REASON OF ANY INTEREST.

(I) IN THE ABSENCE OF FRAUD OR BAD FAITH, ANY DIRECTOR, OFFICER, OR STOCKHOLDER OF THIS CORPORATION MAY BE A PARTY TO OR OTHERWISE INTERESTED

IN ANY CONTRACT, TRANSACTION OR OTHER ACT OF THIS CORPORATION.

(J) NO DIRECTOR SHALL BE LIABLE TO THE CORPORATION OR ITS STOCKHOLDERS FOR DAMAGES FOR BREACH OF FIDUCIARY DUTY AS A DIRECTOR EXCEPT TO THE EXTENT

EXCULPATION FROM LIABILITY IS NOT PERMITTED UNDER LAW.
