**NOTICE OF ENTRY OF ORDER CONFIRMING THE DEBTORS'

TO CREDITORS, EQUITY INTEREST HOLDERS, AND OTHER PARTIES IN INTEREST:

PLEASE TAKE NOTICE that an order (the "Confirmation Order") confirming the Debtors' Joint Plan of Reorganization Under Chapter 11 of the Bankruptcy Code, dated December 18, 2001 (as amended, the "Plan"), of Sun Healthcare Group, Inc. and the other above-captioned debtors and debtors in possession (collectively, the "Debtors"), was signed by the Honorable Mary F. Walrath, United States Bankruptcy Judge, and entered by the Clerk of the United States Bankruptcy Court for the District of Delaware (the "Bankruptcy Court") on February 6, 2002. Unless otherwise defined in this notice, capitalized terms used in this notice shall have the meanings ascribed to them in the Plan and the Confirmation Order. A list of the Debtors is attached hereto as Exhibit "A."

PLEASE TAKE FURTHER NOTICE that the Confirmation Order is available for inspection in the office of the Clerk of the Bankruptcy Court at the United States Bankruptcy Court, 824 Market Street, Fifth Floor, Wilmington, Delaware 19801. The Confirmation Order is also available on the Debtors' website: www.sunh.com. The effective date of the Plan occurred on February 28, 2002 (the "Effective Date").

PLEASE TAKE FURTHER NOTICE that the Plan and its provisions are binding on the Debtors, the Reorganized Debtors, the Disbursing Agent, any entity acquiring or receiving property or a distribution under the Plan, and any holder of a Claim against or Equity Interest in the Debtors, including all governmental entities, whether or not the Claim or Equity Interest of such holder is impaired under the Plan and whether or not such holder or entity has accepted the Plan.


