5. That said Receiver is hereby discharged and the Receivership Bond ordered cancelled;

6. That the Defendants' corporations are hereby ordered dissolved and the Receiver is directed to forward a copy of this Order to the Office of the Secretary of State for the State of Rhode Island; and

7. That this proceeding is now closed and may be reopened only upon the filing of a Motion.
