**Business Corporation
Articles of Incorporation**

(Chapter 7-1.2- of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Alex Garcia Enterprises, Inc. (AGE)

This is a close corporation pursuant to § 7-1.2-1701 of the General Laws, 1956, as amended. (Uncheck if inapplicable.)

ARTICLE II

The total number of shares which the corporation has authority to issue is:

ALL SHAREHOLDERS ARE PERMITTED TO VOTE BY WAY OF PROXY SOLICITATION, VOTING TRUSTS, AND POOLING OF INTERESTS AGREEMENT. THERE MUST BE A QUORUM MET AT EVERY MEETING OF THE BOARD OF DIRECTORS. PURSUANT TO THE REVISED MODEL BUSINESS CODE ANNOTATED (RMBCA), THE SHAREHOLDERS VOTE TO ELECT THE MEMBERS OF THE BOARD OF DIRECTORS, AND THE DIRECTORS THEN SELECT THE CORPORATE EXECUTIVES. STAGGERING THE BOARD IS ALSO PERMITTED TO VOTE WITH REGARDS TO SHAREHOLDERS AND DIRECTORS OF ALEX GARCIA ENTERPRISES, INC.. THE DIRECTORS MUST CONFORM TO THE SPECIFICATIONS SET FORTH BY THE BUSINESS JUDGMENT RULE AND MUST NOT USURP A CORPORATE OPPORTUNITY ACCORDING TO THE CORPORATE OPPORTUNITY DOCTRINE. INTERESTED DIRECTOR TRANSACTIONS AND SELF-DEALING ARE ALSO EXPRESSLY FORBIDDEN BY ALEX GARCIA ENTERPRISES, INC..

The corporation has the purpose of engaging in any lawful business, and shall have perpetual existence until dissolved or terminated in accordance with Chapter 7-1.2.

Additional provisions, if any, not inconsistent with Chapter 7-1.2 which the incorporators elect to have set forth in these Articles of Incorporation:

ALEX GARCIA ENTERPRISES, INC. (AGE) IS GOING TO BE ENGAGED IN THE MUSIC BUSINESS AS A RECORD LABEL. HOWEVER, THE RMBCA HAS ABOLISHED THE CONCEPT OF ULTRA VIRES TRANSACTIONS. AS SUCH, IT WOULD BE OF NO CONSEQUENCE IF ALEX GARCIA ENTERPRISES, INC. CHOSE TO DO BUSINESS IN ANOTHER INDUSTRY SEPARATE FROM THE MUSIC BUSINESS. IN THIS EVENT, THE INCORPORATORS OF ALEX GARCIA ENTERPRISES, INC. WOULD AMEND THE ARTICLES OF INCORPORATION TO REFLECT THEIR NEW BUSINESS DEALINGS. BYLAWS ARE NOT REQUIRED BY LAW, AND THE CORPORATE EXECUTIVES AND/OR DIRECTORS OF ALEX GARCIA ENTERPRISES, INC. (AGE) MAY CHOOSE TO DRAFT BYLAWS OR DECIDE NOT TO DRAFT THEM UNTIL A LATER DATE.
