#### **EXHIBIT A**

- 1. The corporation is a professional service corporation acting pursuant to the authority contained in Chapter 7-5.1 of the Professional Service Corporation Law.

- 3. The corporation may provide, either in the corporation's bylaws or by contract, for the indemnification of directors, officers, employees and agents, by whomever elected or appointed, to the full extent presently permitted by law; provided, however, that if the applicable law is hereafter modified to permit indemnification in situations where it was not theretofor permitted, then such indemnifications may be permitted to the full extent permitted by such law
