ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws of Rhode Island, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is The Inner Advocate Mentor Network
2. The period of its duration is (if perpetual, so state) perpetual
3. The specific purpose or purposes for which the corporation is organized are:
The purpose of this non-profit corporation is to foster the development of leadership potential in
Rhode Islanders from 8 to 16 years of age, who have experienced marginalization.
The leadership possibilities within each child served by this non-profit will be nurtured
by the facilitation of their own creative self-expression through the medium of the
expressive arts, such as writing, visual arts, music, dance, theater, film making, public
speaking and/or other types of design based work. Through this process of self-expression,
each individual served by this non-profit will gain invaluable tools for self-awareness,
self-empowerment and self-realization. A public presentation of projects will be given annually.
4. Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:
 - a) Monthly meetings to be held at the non-profit office on the fourth Wednesday of
every month, excluding holidays, unless otherwise verbally agreed to by 2/3 of Board.
 - b) Board will include President, Treasurer and Secretary.
 - b) Board will have full passage of regulations and policies with a 2/3 majority vote.
 - c) Amendments to charter official documents may be made part of whole by 2/3 majority vote.
