During the past three years, the Board has not received any information on allocation of funds or any transactions made into the Johnston Senior Citizens Center Inc. account. The purpose of this account was to bank money raised by the Board to benefit the Johnston Senior Center. The account had approximately \$38,000 which the Board voted unanimously on August 22<sup>nd</sup>, to use these funds for a Portico. On August 23<sup>rd</sup>, we learned that the funds had been withdrawn in the form of two certified checks from Bank of RI by Barbara Graziano.

By-laws were discussed.

Cythina Galipeau moved to open a new bank account and amend the current Annual Report. David aRusso seconded the motion. The new Chairman, John Dick and the new Treasurer, Benjamin Haskins will open a new bank account and Peter Lombardi will amend the RI Non Profit Corporation Annual Report to reflect the new officers. The new account will require two signatures, that of the Chairman and that of the Treasurer. The votes were unanimous.

David aRusso motioned to have John and Ben request an account record from the old bank account to audit all transactions that were made during the past three years. Peter Lombardi seconded the motion. The votes were unanimous.

In the interim, we are requesting that all funds that were withdrawn be returned to the new Board.


John Dick moved that once these funds are disbursed back to us that we use the funds for the Portico. Linda Quinn seconded the motion. The votes were unanimous.
