
CONSENT ORDER

1. That Judgment hereby enters in favor of Plaintiff Glynn Electric, Inc.
2. That Plaintiff shall be permitted to file Annual Reports for 2002-2013 along with payment of the applicable fees in the amount of \$600 to the Secretary of State.
3. That Plaintiff shall be permitted to pay applicable penalty fees in the amount of \$550, if all documentation set forth herein is filed by October 7, 2013, otherwise the amount of \$600.00, to the Secretary of State.
4. That Plaintiff shall be permitted to file a Letter of Good Standing from the State of Rhode Island Department of Revenue Division of Taxation with the Secretary of State.
5. That upon completion of the foregoing, Plaintiff's certificate of revocation shall be withdrawn and its certificate of authority to transact business in the State of Rhode Island shall be retroactively reinstated as of October 7, 2002.




