Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Kairos Integral Evangelistic Ministry

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

- 1.- To operate as a community local, national and International evangelistic ministry.
- 2.-Preach the Gospel of Jesus Christ
- 3.- To preach the gospel with the media: Radio, T.V., Printed Material and Internet.
- 4.- To conduct religious worship services at homes, elderly homes, prisons, parks, streets, hotels, convention centers and churches.
- 5.- Promote Missionary trips to Africa and Latin America and The Caribbean.
- 6.- To help the needed orphan of Africa
- 7.- To Open Local, National and International Churches.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

- 1.- THE PRESIDENT WILL SERVE AS PERPETUAL.
- 2.- VICE PRESIDENT, SECRETARY AND TREASURE WILL SERVE A PERIOD OF TWO YEARS, AND BE REELECTED UNLIMITED.
- 3.- IN CASE OF THE TERMINATION OF THE ORGANIZATION, ALL ASSETS WILL BE GIVEN TO ANOTHER ORGANIZATION OF SAME NATURE.
- 4.- ALL OF THE OFFICIALS OF THIS ORGANIZATION ARE TO BE IN GOOD CHRISTIAN SPIRITUAL STANDARDS ACCORDING TO THE BIBLE.
ALL OFFICIAL MUST ATTEND A MINIMUM OF 4 MEETINGS EACH YEAR.
- 5.- THE REGULATIONS OF THIS ORGANIZATION CAN BE AMENDED BY THE DETERMINATION OF THE BOARD OF DIRECTORS, BUT NEVER TO CHANGE THE NATURE FOR WHICH IS CREATED.
