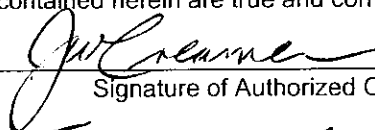
**APPLICATION FOR CERTIFICATE OF WITHDRAWAL**
